



JOB TITLE: Supply Chain Manager

DEPARTMENT: Operations

REPORTS TO: Supply Chain Director

SUMMARY: The Supply Chain Manager will execute or supervise activities related to forecast planning, supply planning, procurement. Develops implements and maintains policies, procedures and material control systems. Ensures materials are ordered and in stock to meet company requirements, while maintaining acceptable inventory levels. Develops schedules and coordinates the efficient movement of materials with CM, and engineering. Reviews and plans requirements for purchasing of finished goods, and NPI. Will prepare materials requirements demand, requisitions and purchase orders using ERP systems. Primary "checker" for ECO releases.

DUTIES AND RESPONSIBILITIES:

1. Planning and scheduling of production ready and NPI products
 - Leads the forecast aspect of the backlog meeting. Plans, schedules, and implements production build requirements with CM.
 - Manages the production status meeting with CM, evaluates delivery risks, and works to mitigate obstacles and barriers with the CM.
 - Communicates all schedules and delivery impacts to customers
2. Contract Manufacturer Tier 1 Supplier
 - Primary interface to CM
 - Execute supply and demand planning, procurement & scheduling
 - Implement ECOs
 - Manage E&O
 - Direct, manage and execute NPI implementation
 - Clear hard to get material for CM
 - Implement cost reductions
 - EOL status and management
 - Participate in solving quality issues
3. Customer Communication
 - Manage customer communication on forecast & shipments.
4. Manage and Execute Tier 2 supplier activities in support of production ready product
 - Supplier selection, qualification, and communication
 - Supplier OTD
 - Supplier cost
5. Help to develop and recommend forecast and delivery requirements to suppliers.

6. Core team member on many Quake projects and goals such as, drop ship, tool move, OTD, cost down, RMA clean up, inventory value reduction, NPI, etc
